The school will:

- recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;

- develop a practice of openness with parents and encourage parental involvement in the education of their children; and
- fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.

- Risk of harm due to bullying of a student.
- Risk of harm due to racism.
- Risk of harm due to inadequate supervision of students in school
- Risk of harm due to inadequate supervision of students while attending out of school activities
- Risk of harm due to inappropriate relationship/communications between student and another student or adult
- ➤ Risk of harm due to students inappropriately accessing/using computers, social media, phones and other devices while at school or at home.
- ➤ Risk of harm to students with AEN who have particular vulnerabilities including medical vulnerabilities.
- Risk of harm to student while a student is receiving intimate care
- Risk of harm due to inadequate school policy in a particular area
- > Risk of harm in one-to-one teaching, counselling, coaching situation
- Risk of harm caused by member of school personnel communicating with students in an inappropriate manner via social media, texting, digital device or other manner
